<u>WELCOME AND CHALICE LIGHTING</u>: Vanessa read the land acknowledgment and marissa shared chalice lighting words from Linnea Nelson.

<u>COVENANT, CHECK IN AND ACCESS NEEDS</u>: Tony read the Board covenant. Board, staff and guest shared a check in and access needs.

MINUTES: The minutes from the May 19, 2021 board meeting were approved as amended.

CONVERSATIONS FOR CONNECTION PROPOSAL: Lisa and Tony reported on the work which has been done to develop a program for small group conversation to be introduced this summer. It will be a structured series of three facilitated sessions during which congregants will be invited to speak from their personal opinion on important issues in the life of the congregation.
